Europorte, a major player in rail freight and rail infrastructure management in France, has announced the signature of an agreement to acquire, through its subsidiary SOCORAIL, a 20% stake in T.S.Rail (Track Solution Rail), a company specialising in maintenance, works and engineering studies for railway installations and tracks.

Through this acquisition, Europorte is broadening the potential of its offering and activities, opening the way to new projects to serve its current and future customers.

T.S.Rail (Track Solution Rail) is a holding company comprising 5 subsidiaries (SOMARAIL Nord, SOMARAIL Sud, SOMARAIL Est, SOMARAIL Réseau and INGEFER), with a total workforce of almost 140 and sales of €25 million in 2022. Headquartered in Grande-Synthe (59), the company offers a wide range of technical and intellectual services on the national rail network, branch line terminal installations and local and port railways.

The company will be chaired by Pierre Dezoomer in his capacity as majority shareholder and Chairman of the subsidiaries.

The deal offers the two companies new opportunities for collaboration, as well as complementary geographic coverage in a market undergoing major transformation.
